Please describe the complaint

• The Open Source Iniative, hereafter knows as OSI, used a third party vendor for elections. The 3rd party is hosting that information live with a search function still in place of 589 members and indicates who voted and who did not. There was and still is an expectation of privacy with regard to membership and voting data. The main point is the OSI did not do due diligence to protect our privacy, and after a week of knowing the list was public still have not resolved this issue. The list includes first and last names and whether the person voted or not. This list is still publicly available. *The membership was paid and then, after researching the bylaws, they also were never to have members in the first place - Title IV OSI Bylaws.

Please describe any materials you have supporting the complaint

• I have a forum post where the Director of Open Source Initiative states he does not know how the list was publicly available and the IT department is looking into it. The Director also mentioned the list was on a private secure server, but they did share with the 3rd party and woefully neglected - for 4 years to ensure our data privacy. I have screenshots and video of their claims of privacy. The Helios site is still up. I have captured video of the extent of public membership availability being 589 members with 209 casting votes.
