Learning Technology Advisory Council Summit and IMS GLC Quarterly Meetings-16-19 July 2007

Microsoft, Redmond, Washington

Over 90 people joined us for a great quarterly meeting and Learning Technology Advisory Council the 16-19 July at Microsoft in Redmond, Washington.

Work progressed in Enterprise Services, Common Cartridge, Learning Tools Interoperability, Learning Object Discover and Exchange, Technology Enabled Flexible Learning (nee Standards for Distance Learning), Accessibility, and Common Cartridge K12 groups.

We had a very good Member Meeting on Tuesday afternoon, where we discussed changes to the Technical Advisory Board Policies and Procedures, namely the creating of Application Profile Management Groups (APMGs) and Conformance.

Thursday was the kick off of the Learning Technology Advisory Council (LTAC). The LTAC is charged with identifying and prioritizing effective practices and standards for the application of learning technologies, in addition, the LTAC will explore emerging technologies and their implications for LTAC-related activities.

Finally, the first TestFest also took place on Thursday. The TestFest allowed Common Cartridge Alliance members to test Common Cartridges, experiment with the CC test data set and exchange information on implementing CC.

| Group | Description |

| QTI Assessment Project Group | The QTI Assessment Project Group is gathering contributing member commitments to begin developing profiles of the QTI v2.1 specification. |
| Content Packaging Project Group | The Packaging Project Group has completed the CM/DN Draft and is now available to IMS Contributing Members and Developers Network subscribers for implementing. The one-year adoption period before the spec becomes Final (1Q 2008) is underway. |
| Common Cartridge Project Group | The Common Cartridge Project Group has completed the v1.0 CM/DN Draft of the specification and is preparing the final specification. |
| Enterprise Services Project Group | The Enterprise Services Project Group is working on the Base Document draft version of the Enterprise v2.0 specification. |
| Learning Tools Interoperability Project Group | The Learning Tools Interoperability Project Group is working on the Base Document draft of the LTI specification. |
| Learning Object Discovery and Exchange PUFSIG | This group, recently renamed from Federated Architectures, is working on a charter to define the objectives of what it plans to accomplish in regards to organizing learning resources and repositories. |
| Accessibility PUFSIG | The Accessibility group is participating with other IMS Project Groups to ensure accessibility issues are addressed and is also developing a charter to look at updating the set of IMS Accessibility specs. |
| K12 Common Cartridge PUFSIG | This group is focused on the K12 space with regard to curriculum management and content exchange, looking at which standards can be applied as possible solutions. |
| Technology-enabled Flexible Learning PUFSIG | This group, recently renamed from Standards for Distance Learning, is working to recommend and assess practices for implementing academic programs in the online context. The work may eventually lead to a certification process. |
