You are hereby summoned to the oral proceedings in the above case.
The proceedings are scheduled to take place

on 28.05.21 at 09:00 hrs

by videoconference (VICO)

The oral proceedings held by VICO will be public (public access to the VICO hearing will be provided; for more details, please consult the homepage of the Boards of Appeal).

You are requested to connect to the VICO system at least **15 minutes** before the start of the hearing, so that your ID (and authorisation) may be checked in advance.

The EPO supports the following technologies for connecting to oral proceedings in appeal held as a videoconference:-

- Zoom desktop client installation on Windows, Mac OS (version 4.5.3261.0825 or higher)
- Zoom mobile App for iOS (version 4.5.0 [3261.0825] or higher) or Android (version 4.5.3261.0825 or higher).

You are furthermore reminded of the following:

- if a party who has been duly summoned to oral proceedings fails to connect to the Board's VICO system for reasons other than technical problems, the proceedings may continue without that party (Rule 115(2) EPC; Article 14(4) Rules of Procedures of the Enlarged Board of Appeal).
- oral proceedings will only be postponed at the request of a party for serious reasons (see Article 14(3) of the Rules of Procedures of the Enlarged Board of Appeal).
- as regards filing authorisations for representatives or company employees, see Decision of the President of the EPO dated 12.7.2007 on the filing of authorisations in Special edition No. 3 OJ EPO 2007, 128.

In that case, a decision on the points of law referred to the Enlarged Board could be promptly issued.

Oral proceedings in appeal held as a videoconference at the Boards of Appeal of the European Patent Office - technical guidelines

The technical infrastructure has been put in place now to enable the holding of oral proceedings held as a videoconference in appeal requiring simultaneous interpretation and/or several parties. Users interested in holding such oral proceedings should familiarize themselves with the following technical requirements and recommendations.

Supported systems

The EPO supports in these cases the following technologies for connecting to oral proceedings in appeal held as a videoconference:

- Zoom desktop client installation on Windows, Mac OS (version 4.5.3261.0825 or higher)
- Zoom mobile App for iOS (version 4.5.0 [3261.0825] or higher) or Android (version 4.5.3261.0825 or higher).

If you have any of the above Zoom setup you are advised to run a compatibility test of your equipment with the EPO, preferably at least 10 working days before the oral proceedings are due to take place (see "Test call" below).

Please note that due to its limited functionality, the Zoom Web client is not suitable to attend oral proceedings in appeal requiring simultaneous interpretation. It is thus not possible to use the Zoom Web client.

General requirements

- System

Please make sure to use a powerful computer running a recent Windows, or Macintosh operating system to prevent resource issues for the Zoom desktop client application. The same applies to your mobile device if you want to use Zoom mobile App for iOS or Android.

- Bandwidth

Please make sure enough Internet bandwidth is available. You should have at least 2Mbps of free up- and download bandwidth. A cabled network connection is preferable over a wireless connection.

- Camera

Please use a good quality webcam (HD 720p or above), preferably a PTZ (Pan-Tilt-Zoom) model. Please be advised that most built-in webcams do not deliver the required quality and flexibility.

- Audio

Please use a high quality audio device, e.g. microphone and speakers or a headset with a frequency response of at least 125 Hz to 15000 Hz) and an echo-cancelling function (preferably a wired headset certified for Zoom (<https://support.zoom.us/hc/en-us/articles/360026690212-Supported-USB-HID-devices-for-the-Zoom-Desktop-Client>)).

- Monitor/Screen

Please make sure a good quality monitor/screen is used; the larger the screen the better the legibility.

Test call

Users are strongly advised to perform a test call in good time prior to the date of the appeal oral proceedings, i.e. at least 10 working days in advance.

The EPO offers the possibility for test calls on Mondays to Fridays (except days on which the EPO filing offices are closed, <https://www.epo.org/service-support/holidays.html>) from 13:00 to 16:00 hours CET.

A test call can be arranged by contacting the EPO Serviceline on Mondays to Fridays (except days on which the EPO filing offices are closed, <https://www.epo.org/service-support/holidays.html>) from 7:30 to 18:00 hours CET, by telephone +31703404444 or by e-mail serviceline@epo.org.

EPO Serviceline will schedule a 30 minutes test session and send you an invitation with the connection details for the call.

Goals that need to be met in the test are:

- Use of the Zoom Desktop application
- A stable connection, both audio and video should be of adequate quality
- Presentation of content should be possible in both directions.

Privacy

During the pilot phase, the ZOOM general privacy statement applies, including the aspects about collected data, how they are used, retention policy, security, and specific privacy rights for European residents: Zoom privacy statement (<https://zoom.us/privacy>).

The EPO will keep connection details as communicated by the parties as non-public information.

EPO data protection guidance when using Zoom for oral proceedings by VICO

Oral proceedings in appeal organised through Zoom Video Communications: information for users regarding data protection

Zoom Video Communications ("Zoom") is a cloud-based videoconferencing (VICO) platform enabling the successful organisation of events in a virtual environment such that effective interaction between participants is as close as possible to a face-to-face experience.

With a view to the needs of patent proprietors and users to continue enjoying access to all patent procedures the EPO has decided to launch a pilot project in appeal by videoconference. Within this framework, Zoom is tested to hold proceedings which require simultaneous interpretation and/or multiple parties.

This pilot project forms part of our Business Continuity <https://www.epo.org/news-events/covid-19.html> scenario (launched in response to the operational disruption caused by the coronavirus pandemic). As such, the data processing operation is based on Article 5(a) of the EPO Data Protection Guidelines <https://www.epo.org/about-us/office/data-protection-and-privacy.html> ("processing is necessary for the performance of a task carried out on the basis of the EPC or in the exercise of official authority vested in the EPO").

Personal data is processed by the EPO for the purpose of organising these oral proceedings.

For more information on the processing of personal data by Zoom or its subcontractors, please consult their privacy policy (<https://zoom.us/privacy>). Zoom signs agreements with all its service providers that prevent them from processing of data for their own purposes or for the purposes of another third party.

When the EPO organises an oral proceeding on the Zoom platform and invites the parties to dial-in, we will do so according to the most secure options available; the EPO nevertheless strongly recommends its users to not share any confidential data when exchanging information using Zoom. The data processed by Zoom for the purpose of oral proceedings in appeal by VICO is as follows.

- username;
- general information about service preferences;
- information about each user's device, network and internet connection, such as IP address(es), MAC address, other device ID (UDID), device type, operating system type and version, and client version;
- information about usage of or other interaction with Zoom Products ("Usage Information");
- other information the user uploads, provides or creates while using the service;
- metadata used for the maintenance of the service provided;
- optional data: telephone number of a person making a call using Zoom services (e.g. Zoom Phone) and data collected through the use of cookies and tracking pixels (only in case the user visits one of Zoom marketing website).

Additional data could be collected depending on whether the user joins the virtual event through an Android or an iOS device. As part of the nature of a collaborative tool, additional personal data may be included in the information that is exchanged between the Office and stakeholders, such as instant messages, images, files, whiteboards, recordings (if previously agreed), contacts, metadata used for the maintenance of the service provided.

Personal data processed by the data controller or the service providers under its supervision are generally stored for the period of time necessary to achieve the purpose for which they have been processed.

This guidance will be further developed during the course of the pilot project.
