Ms Bergot hinders the functioning of the CSC

Dear Mr Battistelli,

In the past two weeks, Ms Bergot has made it very difficult - if not impossible - for the members of the Central Staff Committee (CSC) to meet in person. She has acted inconsistently by cancelling already granted duty travel requests and has created several new limitations.

The facts substantiating these statements can be found in the Annexes.

With all due respect, it is not the role of Ms Bergot, Head of the HR Department, to define:

- who can attend an internal meeting of the Central Staff Committee (CSC) (e.g. no alternates, no experts, no local members),
- how long the meeting should last (e.g. only 1 day).
- how we should organize the meeting (e.g. video-conference, lists by email)

Hindering the work of the CSC is not going to help fostering social dialogue. In the past, the CSC was able to meet in person around 10 times per year for about 2.5 days. Video conferences and emails are already used very frequently by the CSC but are no proper substitute to live meetings. Contrary to a structure with a more centralized and hierarchical approach, staff representatives are elected and based at different sites. They do need to meet in person and discuss central staff issues, in order to express more coherently the interests of staff (Article 34(1) and (3) of the Service Regulations). It is all the more necessary, at European Patent Office a time you want to introduce complex and far reaching changes, for 80339 Munich example on the career system, the partial compensation scheme or the Germany invalidity scheme.

Finally, in her email of 1 October (Annex 8), Ms. Bergot complains about the alleged use of "aggressive level of language and a tone not befitting www.epo.org the standards of communication expected from international civil servants" by a few GCC (or CSC?) members without documenting it. We fail to understand what Ms Bergot is referring to and hope that disagreeing with the EPO HR policies and/or HR managers is still allowed since the entry into force of "social democracy".

Regardless of whether Ms Bergot is acting on your behalf, we kindly request that you instruct her to stop such interferences. In the mean time we have the duty to inform staff by making this letter open.

Subject: RE: CSC Nomination for Statutory Bodies: Internal Appeals Committee

Dear CSC members,

The question of duty travels and live meetings of the CSC seems to have taken priority on other issues in our regular comunications. Therefore I will propose to finalise next week the discussions on resources granted to the staff representation under circular 356. An invitation will be sent asap.

I understand that the selection of a chairman as well as appointments in statutory bodies are important topics for the sound functioning of the social dialogue. Nevertheless, I fail to see the direct connexion between these appointments and the need for a 3 days live meeting (including non CSC members). The Administration has to appoint itself each year members of the same bodies, which does not require duty travels but simple exchanges of a list per email. Recent experience has also demonstrated that such CSC meetings are not a guarantee to proceed to the expected appointments.

As a meeting of the GCC is foreseen on 10.10, I can agree that members of the GCC participating to this meeting may also meet on 9.10 in order to prepare the GCC meetings.

I take this opportunity to remind you of some basis rules concerning the relations and communications with the HR colleagues working on the administration of social dialogue or in charge of approving your duty travels. Since the entry into force of the new social framework, some members of the GCC have regularly used an aggressive level of language and a tone not befitting the standards of communication expected from international civil servants. This behaviour puts an undue pressure on colleagues, who are just trying to respect the rules of the duty travel policy, as applied to all staff. I tried to address this issue informally at individual level with some of you, apparently to no avail. In order to avoid unnecessary escalation, these colleagues and myself have so far not started any formal step.

I am now in the obligation to inform you more officially, that no new incident will be tolerated and remain unanswered.

I apologize for the majority of the CSC members who remain respectful and professional, and should not feel concerned by this general reminder.

I thank you for your understanding.
